Our work with the **YWCA** of Halifax to develop and implement a three-year developmental and outcome evaluation for *Shift Change*, a project that seeks to improve women's economic security and prosperity by addressing the barriers to the participation and advancement of women in the skilled trades sector, continues. We are building connection, inclusion, and commitment to accessible employment for women and all genders. Our developmental evaluative process has informed our thinking and next steps.

#### **■ Fountain of Health** • (Jean, Vicki)



Our ongoing project management of the **Fountain of Health** (FoH) initiatives continues, supporting national and Nova Scotia teams and projects. Our work on the Affinity Fund project, *Thrive MD*, has wrapped up and the final report sent off to the funders. Most recently, we have supported the initiative's work to find sustainable funding, and the updating of the *Optimal Aging* workshops. We also supported the fall rollout of the *5 Minute CBT* course for clinicians that just wrapped up and are now promoting the next offering in February. **Jean**'s son, **Lee**, has also shared his technical skills for this work, editing each session's recording to share with participants.

#### ■ Nova Scotia Health, Mental Health & Addictions • Evaluation of the Adaptive Mentorship Network – Pain & Addiction • (Jean, Paula)



**Horizons** has begun work with Nova Scotia Health, Mental Health & Addictions to develop and implement a needs assessment framework, an evaluation framework, and create evaluation tools for the *Enhancing Peer Support for People Living with Substance Use and/or Concurrent Disorders Project.* This federally funded pilot is launching in two communities within their Recovery Support Centres.

#### ■ Pictou County Community Health Centre Society • Development of an Operational Plan • (Andy, Jean)



This fall we began working with the Pictou County Community Health Centre Society to develop an operational plan for a new Community Health Centre. **Andy Horsnell**, a **Horizons**' Associate, has joined us on this project. We will be developing job descriptions, a human resources framework, administrative requirements, and an initial 1-3 year budget for infrastructure and operations. Our initial work has included a visioning session with Society members to clarify the Centre's potential users, its role, and what is required in the start-up of the Centre.

#### ■ Nova Scotia Health Authority, Mental Health & Addictions • Adaptive Mentorship Network Evaluation • (Jean, Paula)



Our work with the *Adaptive Mentorship Network* to evaluate the scale-up of the network to be more fully engaged in the other Atlantic provinces, outside Nova Scotia, continues. Most of our work since the last newsletter has focused on working with the Centre for Effective Practices, Pain BC, and AMN-P&A to create a common evaluation framework, measures, and data collection tools. Earlier this month, the first intake and baseline surveys were rolled out with mentor and mentee clinicians in Newfoundland and Labrador. Next steps are finalizing the repeat measures and creating focus group and interview guides to capture the rich information from participants.

Spring Into Action Challenge 2023


